NEGOTIATION AGREEMENT

INSTITUTION: STANFORD UNIVERSITY STANFORD, CALIFORNIA 94305

The Facilities and Administrative (F&A) Cost rates contained herein are for use on grants, contracts and/or other agreements issued or awarded to Stanford University by all Federal Agencies of the United States of America, in accordance with the provisions and cost principles mandated by 2 CFR Part 200. These rates shall be used for forward pricing and billing purposes for the Stanford University Fiscal Years 2021 through 2022. This rate agreement supersedes all previous rate agreements/determinations related to these rates for Fiscal Years 2021 and 2022.

DISTRIBUTION BASES

(a) Modified Total Direct Cost (MTDC) consisting of all direct salaries and wages, applicable fringe benefits, materials and supplies, services, travel, and up to the first \$25,000 of each subaward (regardless of the period of performance of the subawards under the award). MTDC excludes equipment, capital expenditures, charges for patient care, rental costs, tuition remission, scholarships and fellowships, participant support costs and the portion of each subaward in excess of \$25,000.

SECTION II - GENERAL TERMS AND CONDITIONS

- A. **LIMITATIONS**: Use of the rates set forth under Section I is subject to availability of funds and to any other statutory or administrative limitations. The rates are applicable to a given grant, contract or other agreement only to the extent that funds are available and consistent with any and all limitations of cost clauses or provisions, if any, contained therein. Acceptance of any or all of the rates agreed to herein is predicated upon the following conditions: (1) that no costs other than those incurred by the institution were included in this indirect cost pool as finally accepted and that such costs are legal obligations of the institution and allowable under governing cost principles; (2) that the same costs that have been treated as indirect costs are not claimed as direct costs; (3) that similar types of costs have been accorded consistent accounting treatment; and (4) that the information provided by the institution which was used as a basis for acceptance of the rates agreed to herein, and expressly relied upon by the Government in negotiating and accepting the said rates is not subsequently found to be materially incomplete or inaccurate.
- B. **ACCOUNTING CHANGES**: The rates contained in Section I of this agreement are based on the accounting system in effect at the time the agreement was negotiated. Changes to the method(s) of accounting for costs, which affect the amount of reimbursement resulting from the use of these rates require the prior written approval of the authorized representative of the cognizant agency for indirect costs. Such changes include but are not limited to changes in the charging of a particular type of cost from indirect to direct. Failure to obtain such approval may result in subsequent cost disallowances.
- C. **PREDETERMINED RATES**: The predetermined rates contained in this agreement are not subject to adjustment in accordance with the provisions of 2 CFR Part 200, subject to the limitations contained in Part A of this section.
- D. USE BY OTHER FEDERAL AGENCIES: The rates set forth in Section I are negotiated in accordance with and under the authority set forth in 2 CFR Part 200. Accordingly, such rates shall be applied to the extent provided in such regulations to grants, contracts, and other agreements to which 2 CFR Part 200 applies, subject to any limitations in part A of this section. Copies of this document may be provided by either party to other federal agencies to provide such agencies with documentary notice of this agreement and its terms and conditions.

- E. **DFARS WAIVER**: Signature of this agreement by the authorized representative of Stanford University and the Government acknowledges and affirms the University's request to waive the prohibition contained in DFARS 231.303(1) and the Government's exercise of its discretion contained in DFARS 231.303(2) to waive the prohibition in DFARS 231.303(1). The waiver request by Stanford University is made to simplify the University's overall management of DoD cost reimbursements under DoD contracts.
- F. **SPECIAL REMARKS**: The Government's agreement with the rates set forth in Section I is not an acceptance of Stanford University's accounting practices or methodologies. Any reliance by the Government on cost data or methodologies submitted by Stanford University is on a non-precedence-setting basis and does not imply Government acceptance.

Stanford and the Office of Naval Research (ONR) have agreed on final Facilities and Administrative (F&A, or Indirect Cost) rates for University fiscal years 2021 and 2022. These rates are effective beginning September 1, 2020.

Performance Start Date: September 1, 2020 through August 31, 2022

For competitive proposals, new awards, or competitive segments with a period of performance start date on or after September 1, 2020, costs will be subject to the final FY21 rates in FY21 and to the final FY22 rates beginning September 1, 2021. The FY22 rates will remain in effect ("fixed") for the life of the award or until the next competitive segment.

Example: for an on-campus research award that begins in FY2021 and continues through FY2022, and FY2023, 57.7% would be applied for FY2021, 57.4% would be applied for FY2022 and all subsequent years (because we do not have rates in place for years after FY2022).

- (1) Award start date is the (period of performance) start date of the award/competitive segment.
- (2) Oracle burden schedules exist from FY98 (9/01/97) onward. Fixed for life (OMB A-21) was adopted for FY99.
- (3) "All Prior" means all schedules include all final fiscal year rates prior to the dates indicated back to FY98 unless otherwise noted.
- (4) Awards subject to the Sponsored Instruction On/Off Campus rates and the OSA rate must use the FY01/02 rates if they have start dates on or after 1/21/00 through 8/31/00. These awards are assigned the FY00, FY01 and FY02 rates and are fixed for life at the FY02 rate. The sponsored instruction and OSA rates went down for FY01/02.
- (5) Awards subject to the Organized Research Off Campus rate must use the FY00 rate if they have start dates on or after 6/28/99 through 8/31/99. These awards are assigned the FY99 and FY00 rates and are fixed for life at the FY00 rate. The Organized Research Off Campus rate went down for FY00.
- (6) Awards with start dates prior to FY98 were charged at the rate in effect for each fiscal year. These awards that are still active in FY98 as well as all awards with start dates during FY98 are fixed at the FY98 rate.

We are using the agreement date in lieu of the signature dates to identify the effective date of the agreement. The agreement date is the date the parties to the agreement intend the rate agreement to be effective. If there is no agreement date, we will use the last signature date.
- (9) The memo "Application of Facilities & Administrative Rates at Stanford" documents the application of F&A rates in more detail. This memo does not note the 8/31/06 date as there is only one sponsored award PAAVD that started on that date. However, this is the date that we first apply the FY07/FY08 rates to awards per this document. (PAAVD has a correct burden schedule FY07_RSCH_ON_GOV)
